## Purchase contract

A \$100 deposit will hold puppy for purchase for this buyer. The deposit will be applied to the purchase price of a puppy. No puppy shall be released or shipped until remaining balance has been paid in full as specified below. The puppy shall be considered sold once deposit is accepted making it unavailable to any other party. Therefore deposit is nonrefundable unless the chosen live pup becomes sick, injured or dies before leaving seller's home. Deposit on unborn litters shall be refunded or held for a future litter if the pregnancy fails, the desired gender is not available, or the chosen puppy becomes sick, injured or dies before leaving sellers home. Should another puppy be available (not sold), buyer and seller may elect that a substitution be made. If refund is not taken when offered and deposit is forwarded to a new litter, aforementioned process shall begin again. Should buyer cancel this contract for any other reason, deposit is nonrefundable. Seller reserves the right to cancel this contract in the event of nonpayment or lack of communication from buyer once litter arrives; therefore it is vital that buyer communicate change in phone, email and address to seller.

Once litter is born, buyer may make payments to seller on remaining balance until puppy is weaned but it is not required. Total balance of puppy (minus deposit) is due in guaranteed funds (Paypal or cash only) upon pick up of puppy or 10 days prior to shipping. If puppy is shipped to buyer, an additional cost of \$275 will apply (subject to increase). Shipping arrangements will be decided upon deposit and confirmed when balance is paid. For the safety and wellbeing of your pup, seller has the right to delay shipment of pup during extreme temperatures. Shipping expenses are the sole responsibility of the buyer.

At their discretion, seller will release pups for pick up at 6 weeks of age or keep pups until 8 weeks of age. Puppies being shipped must remain until 8 weeks of age. Seller will provide all needed care for puppy while at their home. No pup will be released prior to 6 weeks of age. Puppies held with seller after 8 weeks must be paid for in full as well a \$10 per day boarding fee and any needed veterinary care.

All pups will be examined by a veterinarian prior to being released from seller. Should seller be aware of any medical issue prior to leaving their home, seller will inform buyer and price compensation may be offered. Should buyer accept pup upon disclosure of such, seller is relieved of all further liability. Buyer acknowledges that adopting a living being carries an inherent risk for illness or injury at some point in their lifetime. Care and handling of the pup can greatly affect their overall health, bone structure, conformation, disposition and personality and seller does not guarantee such. Since seller has no control of conditions once pup leaves their facility, seller extends a 72-hour health guarantee against any illness or death due to communicable diseases ONLY. Buyer must take puppy to veterinarian within 72 hours of receiving puppy or guarantee becomes null and void. Seller is not liable for any accident or injury to the pup after being picked up at their home or released to the airline carrier. Should illness or death due to communicable disease occur within 72 hours, buyer must contact the seller immediately. Buyer will provide veterinary statement to seller stating the cause of illness or death to be examined by the seller's veterinarian. Should claim be justifiable by both veterinarians, seller will provide a replacement puppy if available or refund purchase price of puppy once puppy is returned to seller or death confirmed by veterinarian. Shipping expenses are NOT refundable. Seller is not responsible for any veterinary expenses after puppy leaves their home. For the protective health and safety of your pup, it is advised that your pup not be permitted in areas where other dogs roam until he or she has received their full vaccination protocol. It is buyer's responsibility to obtain permissions and pay deposits if in a tenant situation. It is also the buyer's responsibility to fully research and understand the commitment involved in pet ownership and be prepared for such. Any puppy purchased from seller will require further training, which is the sole responsibility of buyer.

A copy of the shot & de-worming record will be provided to you and your vet. It is strongly recommended that you contact your veterinarian to establish a vaccination, worming and check up schedule.

Email confirmation of acceptance of terms of the contract will be accepted when deposit has been received. Signed contract must follow if deposit made by electronic funds (paypal).
